1.0 **Public Ruling No. 3/2019**

On 08 August 2019, Inland Revenue Board Malaysia (IRBM) issued first edition of Public Ruling on Business Expenses in Respect of Disabled Persons.

This Public Ruling illustrates the tax treatment of business expenses incurred by a person for:

- employing disabled persons as employees; and
- providing training to disabled persons who are not employees to enable them to seek employment

2.0 Non-Acceptance of Form CP39 and MTD Payment in Cash and By Cheques at All IRBM Payment Counters

Effective 1 September 2019, IRBM will no longer accept manually submitted Form CP39 (Statement of Monthly Tax Deduction), Compact Disk (CD/ DVD), Flash Drive and Diskette as well as cash and cheque payments of the Monthly Tax Deduction (MTD) from employers.
